Keeper Kids Health and Safety Rules

- **Please ensure that you wash your hands before eating or drinking**
- **Tidy up after yourself and check that all litter is placed in the bins provided**

Late or Non-Collection Policy

In the event of a child not being collected at their arranged finish time and a reasonable amount of time has elapsed, 15 minutes, staff will implement the following procedure.

The manager/staff will endeavour to contact their parents/carer using the contact information held on file on the Child's registration form. All reasonable attempts will be made to contact the parents/carer. If Blackpool Zoo is unsuccessful in contacting parents/carer the emergency contact(s) provided by parents on their child's registration form will be contacted and asked to collect the child. In this event the person collecting the child will be asked to state the password provided by parents, this is detailed on the child's registration form. In the event that non-collection occurs the child stays at Blackpool Zoo in the care of two fully-vetted workers until the child is safely collected. If no one collects the child and the staff are no longer available to care for the child, the Duty Manager will decide on the next form of action. A full written report of the incident will be recorded. Depending on circumstances, we reserve the right to charge parents for the additional hours.

Safeguarding

You must allocate a secure password. If another named person other than yourself is collecting your child.

Behavioural Agreement

A list of safety rules have been provided with the application pack. Prior to the programme starting please ensure that the participant understands these rules and that whilst taking part on the course all instructions given by the Blackpool Zoo staff must be followed. Failure to follow these instruction can result in the participant being removed from the activity or the course, a refund for the cost of the course will not be given.

Health and Safety Information

All animals naturally carry a range of diseases, some of which can also affect humans. These diseases are known as zoonoses and during work with animals human's health may be at risk from them. Some of these diseases are not common in Great Britain and good hygiene practices will protect against them. It is essential that all cuts and grazes are covered, and that hands/arms are thoroughly washed before eating or drinking after being in contact with animals or their enclosures. All protective gloves provided must be used and all instructions given by staff must be followed at all times. All of our animals are regularly examined and screened by our vets. Please refer to the health and safety rules attached.

DISCLAIMER: I give permission for the participant to take part on the Keeper Kids programme and I understand that the course involves working with animals and animal contact, and in giving my consent I agree to all of the requirements stated previously, and that in the event he/she contravenes the conditions and safe working practices in place that Blackpool Zoo, its owners, employees or agents, will not be held responsible for any loss or injury sustained.

DECLARATION: I authorise Blackpool Zoo staff to administer or approve any medical treatment of first aid deemed necessary. I agree that Blackpool Zoo has the right to remove any disruptive children from our keeper courses. Blackpool Zoo will not accept responsibility for loss or damages whether to personal acts or property. Photographs/videos may be taken for publicity, advertisement or training purposes. If you wish for your child not to be filmed/photographed please let our staff know. Please be assured your personal details will be protected under the 1998 Data Protection Act. Course Application Forms will be stored in a locked file for quality assurance and auditing purposes.
